

## HUD CoC Program FY23 Application – Section 5. System Performance

- System performance scores:
  - **Count:** A decrease of at least 5% in the number of **sheltered** people in the PIT count 2023 from 2022
    - **Not achieved:** Increase of 28% or 136 more people counted (623 vs 487)
  - **Count:** A decrease of at least 5% in the number of **unsheltered** people in the PIT count 2023 from 2022
    - **Not achieved:** Increase of 121% or 44 more people (62 vs 28)
  - **First Time Homeless:** Reduced number of first time homeless from FY2021 to FY2022 as reported in HDX
    - Metric 5.2 was used in 2022
    - **Not achieved:** Increase of 269 people or 19% (1,657 vs 1,388)
  - **LOT:** Reduced average length of time homeless by 5% or that average LOT homeless was 90 days or less
    - Metric 1.2 was used in 2022
    - **Achieved:** 87 nights (87 vs 82)
  - **Housing:** Increased rate of exits to permanent housing from ES, TH, SH, and RRH by at least 2% or that the rate of exits to permanent housing was 50% or greater
    - Metric 7b.1 was used in 2022
    - **Achieved:** increased by 9% (46% vs 37%)
  - **Housing:** Increased rate of people residing in PSH by at least 1% or that rate of retention was 96% or better
    - Metric 7b.2 was used in 2022
    - **Achieved:** 96% retention rate (96% vs 97%)
      - Rate decreased, but maintained a rate of at least 96%
  - **Returns:** Reduce rate of returns to homelessness within 6 months by at least 1% or the rate of returns to homelessness is 5% or less
    - Metric 2a was used in 2022
    - **Ambiguous:** Rate of returns is 11.2% down 0.8% from 12% last year; score will depend on whether the rate is rounded up or not.
      - The HDX 2023 Competition report cites the rate as 11%.
  - **Returns:** Reduce rate of returns to homelessness within 12 months by at least 1% or the rate of returns to homelessness is 10% or less
    - Metric 2a was used in 2022
    - **Achieved:** Decrease of 1.8% (15.2% vs 17%)
  - **Income:** Increase in % of people increasing income from employment or rate of income from employment was 20% or higher
    - Metric 4.4 was used in 2022
    - **Achieved:** increased by 4% (9% vs 5%)
      - Note that the rate is much less than the target rate of 20%
  - **Income:** Increase in % of people increasing income from non-employment sources or rate of income from employment was 50% or higher
    - Metric 4.5 was used in 2022
    - **Not achieved:** decrease of 4% (15% vs 19%)
      - Note that the rate is much less than the target rate of 50%
