The Capital Region Housing Collaborative (CRHC) announces its local competition for HUD homeless assistance services funding available under the CoC Program for FY 2024 - 2025 This announcement provides further information about the local collaborative application process for Project Applicants in the Ingham County geographic area. (See CRHC website at https://capitalregionhousing.org). Look for the Grants tab at the top of the main page.) The HUD Continuum of Care (CoC) Program (24 CFR part 578) is designed to promote a community-wide commitment to the goal of ending homelessness.

Funding Available: An estimated \$2,958,969 is available for Renewal Projects. All project grants are for two years of funding with varying start dates. See the Grant Inventory Worksheet (GIW) on CRHC's website for specific projects, grant amounts, and funding cycles. This year, the CoC is seeking to reallocate two projects (DVRRH and Permanent Supportive – Bonus). This notice will go out to the CRHC agency network and local newspapers.

Bonus Funding Available: HUD will make up to \$207,128 CoC Bonus funding available for new projects to: 1) create new permanent housing- permanent supportive housing projects (PH-PSH); 2) create new permanent housing-rapid rehousing projects (PH-RRH); 3) create Joint Transitional Housing (TH) and PH-RRH component projects as defined in the FY 2024-25 Notice of Funding Opportunity (NOFO); 4) create Supportive services only coordinated entry (SSO-CE) projects to develop or operate a centralized or coordinated assessment system. New projects must meet the NOFO "rating factors criteria" to be accepted by the CRHC CoC to avoid rejection by HUD. HUD will also make available funding for Domestic Violence (DV) Bonus projects at a minimum of \$50,000 per project up to \$260,258 for: 1) Permanent Housing-Rapid re-housing projects for survivors of DV, dating violence, sexual assault or stalking who are defined as homeless; 2) Joint TH and PH-RRH projects as

defined in the FY 2024-25 NOFO; or 3) Supportive Services Only coordinated entry projects to serve DV survivors. See the CRHC website and FY 2024-25 NOFO for more details.

CoC Program Priorities: The CRHC and HUD have established priorities. See Application form.

CoC Program Description: The CoC Program is designed to promote a community-wide commitment to: 1) the goal ending homelessness; 2) to provide funding for efforts by nonprofit providers, States, Indian Tribes or tribally designated housing entities, and local governments to quickly re-house homeless individuals, families, persons fleeing domestic violence, dating violence, sexual assault, and stalking, and youth while minimizing the trauma and dislocation caused by homelessness; 3) to promote access to and effective utilization of mainstream programs by those who are homeless; and 4) to optimize self-sufficiency among those experiencing homelessness. In summary, HUD priorities are to end homelessness for all persons, use a Housing First approach, reduce unsheltered homelessness, improve system performance, partner with housing, health, and service agencies, address racial equity, improve assistance to LGBTQ+ individuals, incorporate the expertise of persons with "lived experience" defined as those currently or formerly experiencing homelessness, and advocate for the increase affordable housing supply.

FY 2024-25 NOFO CoC Program Components to be funded in this Competition are: Permanent Housing, Joint Transitional Housing (TH Permanent Housing (PH-RRH)

component, Supportive Services Coordinated Entry (SSO-CE) Only, and HMIS Component Projects. See 24 CFR 578.37 for component descriptions and FY2024-25 NOFO Section III. A. and B. for definitions and concepts.

Please note: To be eligible for this funding, organizations must engage in a capacity review process to meet all HUD eligibility requirements and demonstrate experience in managing federal grants, must be registered and maintain registration with the System for Award Management (SAM) before submitting an application; must provide a (UEI) Unique Entity Identifier that is registered and active at https://www.sam.gov/SAM; and engage as an active collaborative agency with the CRHC. Eligible project applicants must be nonprofit organizations in good standing, States, local governments, or instrumentalities of State and local governments, Indian Tribes and TDHE, or public housing agencies. For-profit entities are not eligible.
